Students may apply for course waiver, but not credit exemption, of any prerequisite courses, methodology courses, and fundamental courses of the six research areas. If the student has not completed the prerequisite courses or the student's waiver application is rejected, the student may take elective courses opened by the Institute as prerequisite courses following approval by the Institute.
